BOARD OF REVIEW Tuesday, December 13m 2022 at 1:00 p.m.

Pursuant to the provisions of MCL 211.53b, the Spaulding Township Board of Review will meet in the Township Complex, 5025 East Rd., Saginaw, MI on the above date. The purpose of this meeting is to correct clerical errors or mutual mistake of fact, filings for principal residence exemptions (PRE), and to hear poverty exemption applications.

A word from our Clerk...

Spaulding Township had a safe, secure and accurate election on November 8. Much appreciation is given to our dedicated team of election inspectors and to our deputy clerk in providing great service to voters while ensuring a secure and accurate election.

About 47% of our registered voters exercised their right to vote with 847 ballots cast. 217 of those ballots were from absentee voters. Our County Commissioner, Sheldon Matthews, retained his position even though his district was changed to include Spaulding and Bridgeport Townships. You may remember that Sheldon was a trustee on our township board before taking the county commissioner position.

The recent redistricting in the state caused our township to be split into two State House of Representative Districts, the 93rd and 94th districts. Voters in each of those districts chose the winners as Graham Filler in the 93rd and Amos O'Neal in the 94th.

Other candidates who won their seats with the help of Spaulding voters included Congressman Dan Kildee and State Senator Kevin Daley. The state proposals which all passed state wide were passed in Spaulding except for 22-3 (reproductive rights) which failed in Spaulding. The mosquito abatement proposal passed in Spaulding and in the county while the intermediate school district millage failed in Spaulding but passed in the county.

State proposal 22-2 approval means that there will be changes to voting in the future. Be sure to stay informed to know how those changes may affect you during the next election. You can find more details of the election results on line at electionreporting.com

DEPARTMENT OF PUBLIC WORKS

During the winter months, we ask that if you have a fire hydrant in your yard, to please do your best to keep it clear of snow. Thank you.

A **Water Rate Increase** will be reflected on your April 1, 2023 quarterly bill for usage during the previous three months, i.e. 01/01/23 - 03/31/23. The ready to serve fee which includes 15,000 gallons of water for $\frac{3}{4}$ " meters (the usual size for households) will be increased from \$75.00 to \$85.00, and usage over the 15,000 gallons will be increased from \$4.50 to \$5.10 per 1,000 gallons.

Important Dates – Mark your Calendar

Avoid late fee penalties or disconnection of water service due to nonpayment. Mark your calendar with these quarterly due dates:

First bill is **due** on or before the following dates in order to avoid late fee penalties:

Feb. 10th - May 10th - Aug. 10th - Nov. 10th

Final Notice (second courtesy bill) is **due** on or before the following dates to avoid disconnection of water service. Disconnection would occur on the 11th day of each of the following months:

March 10th – June 10th – Sept. 10th – Dec. 10th

Please keep your telephone number updated!
